

CORNER COMMUNITY PARK CODE OF CONDUCT

THIS CODE OF ETHICS WILL APPLY TO ALL ADULTS INVOLVED WITH CORNER COMMUNITY PARK INCLUDING COACHES, BOARD MEMBERS, PARENTS AND SPECTATORS.

- ** I will place the emotional and physical well being of my players above any personal desire to win.
 - ** I will treat each player as an individual, remembering the large range of physical and emotional development within the same age group.
 - ** I will do my best to provide a safe playing situation for my players.
 - ** I will promise to review and practice the basic first aid principles needed to treat injuries that might occur.
 - ** I will do my best to organize practices that are fun and challenging for all.
 - ** I will lead by example in demonstrating fair play and good sportsmanship.
 - ** I will provide a sports environment that is free from the use of drugs, tobacco, and alcohol, and will refrain from their use during games and practices.
 - ** I will be knowledgeable in the rules of each sport that I coach, and I will teach those rules to my players.
 - ** I will use coaching techniques that are appropriate to the skills, which I teach.
 - ** I will remember that I am a youth sports' coach and that the game is for the children.
 - ** Use of profanity will not be allowed.
 - ** I will pledge to abide by this code of conduct.
1. I will abide by ALL CCP rules & procedures written or as set forth in this handout, by laws, minutes or other oral statements of this organization.
 2. I will display good character at all times on and off the playing location (field or court).
 3. I understand by coaching this year it does not guarantee me a coaching position in the future at CCP in any sport.
 4. I understand that coaching at CCP is a privilege and I will do everything in my control to make sure I represent CCP and myself with respect and dignity at all times.
 5. I understand that the board votes on coaches each year prior to each sport. While doing so, the board takes into consideration my coaching abilities from the previous sport or previous season. I understand that my actions, conduct, and the way I handle situations have a bearing on this decision.
 6. I understand that if the board does not feel I have represented the park or myself appropriately, I will be ask to step down.
 7. I understand that a background check will be completed on me annually. If something inappropriate becomes available, I will step down immediately.
 8. I promise if I do not understand a CCP policy or procedure, I will inquire from a board member or attend a board meeting.
 9. I agree that it is a responsibility of mine as a coach to keep my field / court etc. clean during and after my practices and games.
 10. I understand that if I am ejected from a game 2 times within my coaching career, that I will forfeit my privilege to coach at CCP.

I do understand that the Board of CCP has the authority to ban me from coaching, participating, or attending any sporting event at CCP if they feel that my actions have been inappropriate.
